



California Energy-Smart Homes Single Family Whole Building Electrification Alterations Incentive Program

The California Energy-Smart Homes program is a residential new construction and alterations program that provides incentives to adopt advanced energy measures and transition to all-electric construction. The program supports California's focus on building electrification to meet climate objectives.

Qualifications



Single family properties, including duplexes, townhomes, and accessory dwelling units (ADUs) converting all gas appliances and equipment to advanced electric systems are eligible for whole building electrification incentives.

Eligibility

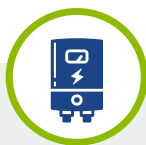
Energy-Smart Homes Single Family Whole Building Electrification Alteration incentives are available to electric utility customers in Pacific Gas and Electric Company (PG&E®), San Diego Gas & Electric Company (SDG&E®), and Southern California Edison Company (SCE®) territories.

Prerequisites

To be eligible, existing single family property owners must convert all gas appliances and equipment to advanced electric systems including:



Heat pump space heating
 (Ductless mini-split heat pumps or residential central heat pumps SEER 15 or greater, HSPS 8.7 or greater)



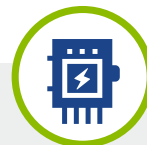
Heat pump water heating



Electric or induction cooking



Electric clothes dryer
 (Bonus incentives are available for heat pump clothes dryers)



Infrastructure upgrade
 (Not required, but bonus incentives are available)

Participation Requirements

- Complete whole building electrification alterations on an existing single family dwelling unit.
- Be located in the PG&E®, SDG&E®, or SCE® electric service territory and pay the Public Purpose Program Charge.
- Provide before and after pictures including photos of equipment name plates for every appliance being replaced and installed.
- Agree to not receive financial incentives for the same measures or scope of work from other CPUC.
- Have work completed by a licensed contractor.
- Meet minimum alteration criteria and equipment specifications.
- Complete and sign an online program participation agreement, including agreeing to program Terms and Conditions.
- Agree to not receive financial incentives for the same measures or scope of work from other CPUC resource-funded programs.
- Adhere to all applicable federal, state, and local laws and codes.
